SABR shall use reasonable efforts to appropriately acknowledge and credit your authorship of any discrete contribution, or otherwise acknowledge and credit your contribution to a collective work published by SABR. SABR agrees to make reasonable efforts to provide you with a complimentary copy of any SABR printed work that includes your contribution, and to make reasonable efforts to provide you with a downloadable copy of any e-book published by SABR that includes your contribution. SABR's failure to provide you with the aforementioned copies or notices shall not affect the validity of this release.

General Release
