BOOK REVIEW STEALING FIRST IN A TWO-TEAM TOWN BY RICHARD C. LINDBERG SAGAMORE PUBLISHING

Rich Lindberg is a loyal White Sox fan. You can tell this from his latest book about the Sox, Stealing First in a Two-Team Town. He is also a loyal White Sox employee, and unfortunately, you can also tell this from his latest book about the Sox. As team historian. Lindberg has a great deal of information at his disposal, and he uses this information to detail the early years of the White Sox. However, he also uses the book to take some pot shots at the Chicago Cubs owners, the Tribune Company, for having too much power in baseball's ownership, when it was apparent that Jerry Reinsdorf had as much or more power that the Tribune when the strike of 1994 was becoming a reality.

Stealing First is more of a history of the creation and ownership of the White Sox, as opposed to a history of the team itself. The book, however, starts out not with Charles Comiskey bringing his Western League team from St. Paul, Minnesota to Chicago, but with what is a much more important date in the recent history of the Sox, June 30, 1988. It was on this day that thengovernor James Thompson saved the White Sox for Chicago and signed the execution notice for Comiskey Park by convincing enough state legislators to approve a lodging tax to fund construction of a new stadium. This day was the end of a painful three year process for Sox fans, who survived a roller coaster of emotions not knowing where there heroes would be playing in 1989. The forces of opposition to the funding included downstate Illinois legislators who are primarily Cub or St. Louis Cardinal fans and could care less about a team that plays net to the projects on Chicago's South Side, and a group of fans who were willing to give up the team to save the stadium, with the hope that the American League would fill the vacancy. Lindberg paints a vivid detail of how Thompson, assisted by Speaker Michael Madagan and officials of the Illinois Sports Authority, were able to call in enough favors to swing the vote to yes, crushing (again) the hopes of St. Petersburg, Florida in the process.

After this, the book settles down to discuss at length Charles Comiskey and his role in helping to form the American League with Ban Johnson, the early success of the White Sox, the Black Sox scandal and Comiskey's eventual death. An interesting chapter details the formation of the White Sox Rooters Association, who's founders became Comiskey's constant companions, helping him organize the world tour (with the New York Giants) in 1913-1914, and who's hunting trips to Wisconsin became legendary.

After Charles Comiskey's death, the team was taken over by John Lewis (Lou) Comiskey, who before his untimely death in 1939 began the process of rebuilding the Sox, who had fallen on hard times after the scandal of 1919. Lou's death put in motion what would eventually the sale of the White Sox to interests outside of the Comiskey, but not before some painful to read history of the acrimony between Lou's children, Dorothy and Chuck. Even though it was Chuck, as team president, along with famed general manager Frank Lane, who brought the Sox back to respectability in the early 50's, Dorothy and her mother, Grace Comiskey (Lou's widow) controlled the team and resisted every attempt by Chuck to consolidate ownership of the team. A reader here would be advised to have a note pad and

pencil ready, because the fight for total control of the Sox can get a bit confusing.

Eventually, majority ownership of the team was sold to Bill Veeck in 1959, and this team won the White Sox last AL pennant. Veeck sold the team after the 1960 campaign, after making some terrible deals that made the Sox older but not better. The new ownership, under Arthur and then John Allyn, had some competitive teams, especially in 1964 and 1967, but otherwise was generally unsuccessful. The Allyn's were the first owners to openly discuss replacement of Comiskey Park (then White Sox Park), looking at sites near downtown Chicago and also in the suburbs. At one point, Arthur Allyn tried to gain an AFL franchise for the city (to replace the Cardinals, who left for St. Louis in 1960 and played many seasons at Comiskey), so that he could build a multi-purpose stadium. The Chicago Bears effectively squashed Allyn's hopes for a Chicago AFL team, and a new stadium was not forthcoming. The Sox started playing some of their games at Milwaukee County Stadium in 1969 to help offset losses from operations, and the current Brewer owner Bud Selig nearly purchased the team for Milwaukee at this time. John Allyn was able to take full control of the team from his brother, and staved off potential purchases from Milwaukee and Seattle. Lindberg properly points out here that it was John Allyn that saved the Sox for Chicago, not Dick Allen as is regularly assumed. Bill Veeck's second tenure as White Sox owner is discussed, mainly in the context of Veeck's struggle to keep the team and his finances afloat with the new phenomena of free agency. Veeck is portrayed well by Lindberg, which is commendable considering Veeck's dislike for Lindberg's bosses.

The Reinsdorf/Einhorn era is discussed with a chapter called Crisis Years at Comiskey. The chapter contains a chronology of the events leading up to the June 30, 1988 Illinois General Assembly meeting. Lindberg, while obviously on the side of the owners in the fight for the new park, does not pull punches when news reports were critical of Reinsdorf or his partners. The book concludes with Re-inventing a Field of Dreams, the chapter that details the actual building of the stadium (briefly), its short-lived honeymoon with the media (until Camden Yards was opened), and the current White Sox team. Unfortunately, Lindberg concludes the book with some commentary on the future of the team under Reinsdorf, which follows the company line of fiscal responsibility, and also includes an implied threat of the Sox potentially moving again. The book end with this passage - "Don't expect to see any "for sale" signs draped over the old candy store --- for now."

Overall, Stealing First in a Two Team Town is an excellent history of the ownership of a major league team. Many of the older American and National League clubs have ownership stories similar to this one. It would have been better, though, if someone with a little less to lose had added the commentary.
